

# MINERAL DEED

KNOW ALL MEN BY THESE PRESENTS:

That **Silver Lining Investments, LLC.**, whose address is **12160 Ashaway Lane, Frisco, TX 75035**, hereinafter called Grantor, for and in consideration of the sum of TEN AND MORE DOLLARS (\$10.00) cash in hand paid, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, does hereby, grant, bargain, sell and convey, transfer, assign and deliver unto:

hereinafter called Grantee, **an undivided interest equal to 5.00/80.00 net mineral acres of GRANTOR'S UNDIVIDED RIGHT, TITLE, AND INTEREST** in and to all of the oil, gas, and other minerals in and under and that may be produced from the following described lands situated in **Sullivan County**, located in the **State of Indiana**, to-wit:

Said warranty is limited to an amount equal to the purchase price. Grantor does hereby agree as to said limited warranty to defend all and singular the said property unto the said Grantee herein its heirs, successors, executors, personal representatives, and assigns against every person whomsoever claiming or to claim the same or any part thereof.
