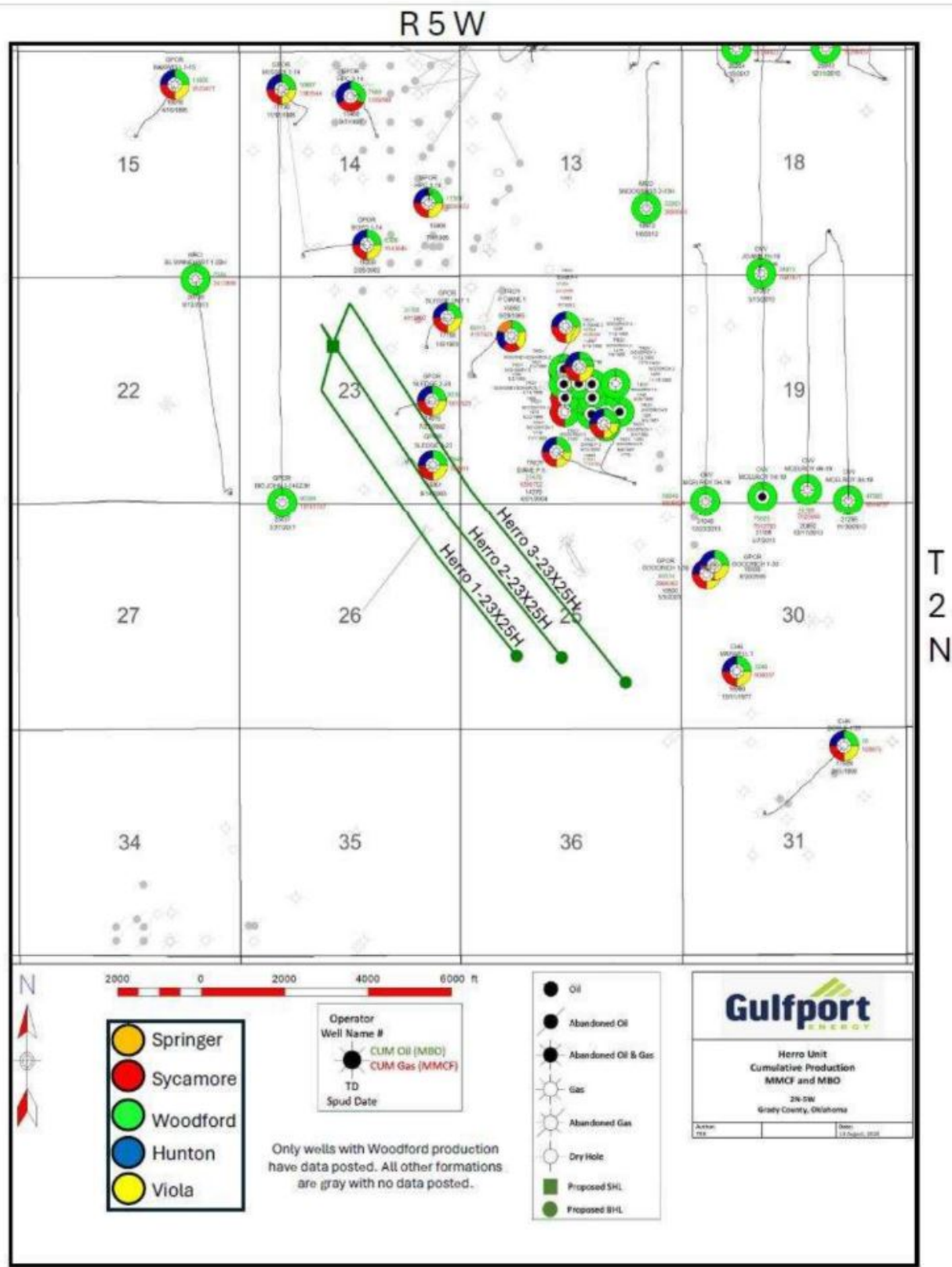

To Whom It May Concern:

Gulfport MidCon, LLC ("Gulfport") hereby proposes the drilling of the Herro 3-23X25H well as a horizontal well from a surface location in the NW NE SE NW of Section 23-2N-5W to a bottom-hole location in the NE NE SW SE of Section 25-2N-5W, Stephens County, Oklahoma at a depth sufficient to test the Woodford Shale formation. The anticipated vertical depth is approximately 14,382' with an approximate measured depth of 25,338'. Please find enclosed an AFE reflecting the total completed well cost of \$17,056,613 (\$9,043,200.00 dry hole cost).

Our records reflect that you own or are claiming to own an interest in this unit and we respectfully request that you elect one of the following options:

1. Lease/Assign your interest to Gulfport, accepting a cash consideration of \$1,600 per net mineral acre reserving a 1/8th royalty interest and delivering an 87.50% net revenue interest for a three (3) year term.
2. Lease/Assign your interest to Gulfport, accepting a cash consideration of \$1,350 per net mineral acre reserving a 3/16th royalty interest and delivering an 81.25% net revenue interest for a three (3) year term.
3. Lease/Assign your interest to Gulfport, accepting \$1,200 consideration reserving a 1/5th royalty interest and delivering an 80.00% net revenue interest for a three (3) year term.
4. Participate in the drilling of the referenced well by executing the enclosed AFE and paying your proportionate share of completed well costs in advance. In the event that you elect to participate under this letter, you must also elect in writing to participate pursuant to the terms of the pooling order to issue or your election to participate WILL NOT be valid.

Options 1, 2, 3, and 4 above are subject to our review and approval of title, and our review and approval of any contract or agreement which may affect your interest in this section. Options 1, 2, 3, and 4 are also subject to withdrawal without prior notice.

1. PARTIES:

Applicant is **Gulfport MidCon, LLC**. Its address is 713 Market Drive, Oklahoma City, OK 73114. **Contact/telephone Landman Scott Cavett, (405) 252-4709**. It is the owner of oil and gas leasehold interests within Section(s) 23, 25 and NE/4 of 26, Township 2 North, Range 5 West, Stephens County, Oklahoma. The parties being made respondents to this Application are set out on Exhibit "A", attached hereto and made a part hereof.

2. ALLEGATION OF FACTS:

(A) The Corporation Commission has established the following spacing underlying Section(s) 23, 25 and NE/4 of 26, Township 2 North, Range 5 West, Stephens County, Oklahoma:

(B) The Woodford common source of supply is the Target Reservoir for a multiunit horizontal well proposed by the Applicant. The Sycamore common source of supply sits immediately above the Woodford common source of supply. The Hunton common source of supply sits immediately below the Woodford common source of supply. The Sycamore and Hunton common sources of supply may be inadvertently encountered in the drilling of the lateral of a horizontal well in the lands involved herein in the Woodford common source of supply if such well drills out of or exits such formation. The Sycamore and Hunton separate common sources of supply are Adjacent Common Sources of Supply with regard to the Woodford common source of supply under 52 O.S. § 87.6.

(C) Applicant has conducted a diligent and meaningful search of the local county assessor's records, county treasurer's records, and county deed records regarding the property involved for return addresses on recorded instruments, county probate records and city and county telephone directories and other sources of such information to locate each respondent.

(D) Applicant, as operator, is proposing to drill a multiunit horizontal well (the Herro 1-23X25H well) in the lands involved herein in the Target Reservoir, with a portion of the completion interval of such multiunit horizontal well to be located in one or more of the 640-acre drilling and spacing unit(s) and 160-acre horizontal drilling and spacing unit(s) formed for the common source(s) of supply named herein above. There is pending with the Commission an application seeking location exception authority for such well. The location proposed for such well is as follows:

The estimated total depth for such well is 22,738 feet. The estimated lateral length for such well is 8,210 feet.

(E) The Commission should allocate to each of the affected units covered hereby the reasonable drilling, completion and production costs associated with the multiunit horizontal well involved herein and the commingled production and proceeds from the completion interval of such multiunit horizontal well. Based upon the information now available, Applicant is proposing that the allocation factor for each of the affected units involved herein should be determined by dividing the length of the completion interval of the multiunit horizontal well involved herein located in each such affected unit by the entire length of the completion interval of such multiunit horizontal well. In the event the lateral of the multiunit horizontal well involved herein stays within the productive portion of the Woodford common source of supply throughout the drilling of such lateral, then Applicant anticipates that approximately 39% of the completion interval of such multiunit horizontal well will be located in said Section 23, approximately 31% of such completion interval will be located in said NE/4 of Section 26, and approximately 30% of such completion interval will be located in said Section 25 with the cost of and the production and proceeds from such multiunit horizontal well is to be allocated between the affected units involved herein based on such percentages. The actual allocation of such costs, production and proceeds may vary depending upon the results of the multiunit horizontal well involved herein.

(F) Attached hereto as Exhibit "B" and made a part hereof is a map showing the location of each currently existing well in each of the affected units covered hereby and the approximate anticipated location of the proposed multiunit horizontal well involved herein. Within

the area in and around the lands covered hereby, there have been very few horizontal wells drilled within the Woodford common source of supply and therefore, the nature and quality, including the potential productivity, of such common source of supply is not known. The results of the multiunit horizontal well involved herein will provide significant information concerning the nature and quality of the Woodford common source of supply in the lands covered hereby which will be used to determine whether any other horizontal wells are necessary within the lands involved herein for the full and efficient development and operation of the Target Reservoir covered hereby within the affected units involved herein. If the multiunit horizontal well involved herein is successfully drilled and if the results of such multiunit horizontal well are significant and if the price of natural gas is favorable, Applicant may potentially drill additional multiunit horizontal wells in the affected units covered hereby if such additional wells are approved by the Commission upon the filing of a proper application therefore at a future date.

(G) The proposed well, at the location requested by Applicant, is necessary to effectively and efficiently drain a portion of the common source of supply covered by the drilling and spacing units comprised of the lands set out in Paragraph A hereof, which cannot be adequately and efficiently drained by a well drilled at the permitted well location prescribed in the Order listed in said Paragraph A.

(H) In order to prevent waste, to protect correlative rights and to aid in the full and efficient development of each of the affected units covered hereby, the Commission should approve the multiunit horizontal well involved herein, including establishing the applicable allocation factor for allocating the cost of and the production and proceeds from such multiunit horizontal well to each of the affected units covered hereby.

3. **LEGAL AUTHORITY:**

The relief requested is authorized by Title 52 Okla. Stat. § 87.6 et seq., and OAC 165:5-7-6.2 and OAC 165:10-3-28.

4. **RELIEF SOUGHT:**

The Applicant in this Cause is requesting the following relief:

(a) An Order approving a multiunit horizontal well (the Herro 1-23X25H well) in the 640-acre drilling and spacing unit(s) and 160-acre horizontal drilling and spacing unit(s) formed for the Sycamore, Woodford and Hunton common source(s) of supply in Section(s) 23 and 25, and NE/4 of Section (s) 26, Township 2 North, Range 5 West, Stephens County, Oklahoma so as to allow such multiunit horizontal well to be drilled as described in Paragraph 2(D) above and to be completed in and to produce hydrocarbons from the above-named common source(s) of supply. The Order should establish a proper allocation factor for allocating the cost of and the production and proceeds from such multiunit horizontal well to each of the affected units covered hereby.

(b) The legal descriptions of the land sections adjacent to the area within which the location exception lies are Section(s) 13, 14, 15, 22, 24, 27, 34, 35 and 36, Township 2 North,

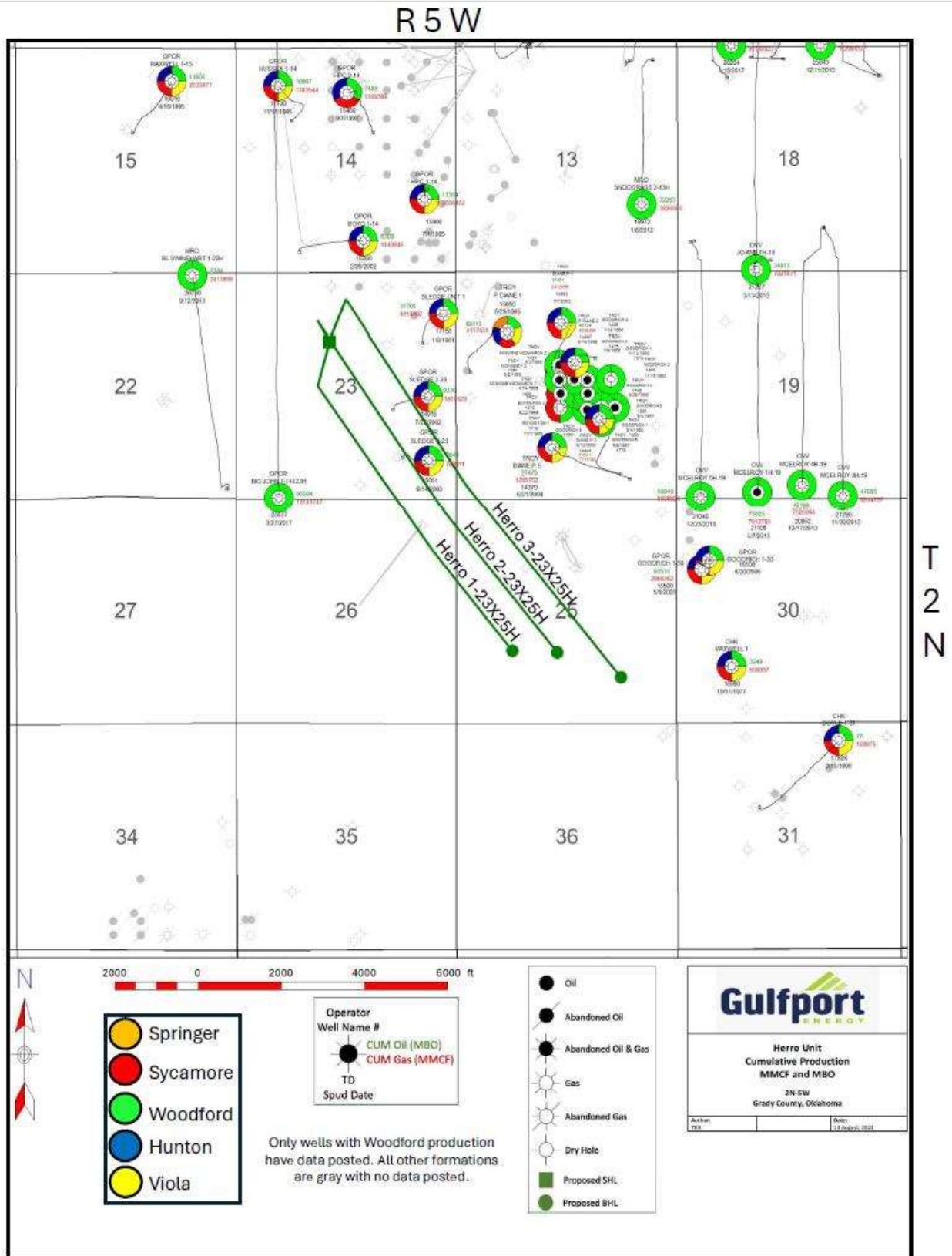
