

MINERAL DEED

KNOW ALL MEN BY THESE PRESENTS:

That **NGame Royalties, LLC.**, whose address is **301 W Main Suite 210, Ardmore, OK 73401**, hereinafter called Grantor, for and in consideration of the sum of TEN AND MORE DOLLARS (\$10.00) cash in hand paid, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, does hereby, grant, bargain, sell and convey, transfer, assign and deliver unto:

hereinafter called Grantee, **GRANTOR’S UNDIVIDED RIGHT, TITLE, AND INTEREST** in and to all of the oil, gas and other minerals in and under and that may be produced from the following described lands situated in **Clark County**, located in the **State of Arkansas**, to-wit:

4.041700 NMA of SW pt SW/4 SE/4; SE/4 NW/4; S/2 SW/4 NE/4; NE/4 SW/4 and Pt SE/4 SE/4 in Section 12, Township 08 South, Range 21 West, Pt N/2 NW/4 in Section 13, Township 08 South, Range 21 West

together with the right of ingress and egress at all times for the purpose of mining, drilling, exploring, operating, and developing said lands for oil, gas, and other minerals, and storing, handling, transporting, and marketing the same therefrom with the right to remove from said land all of Grantee’s property and improvements.

Said warranty is limited to an amount equal to the purchase price. Grantor does hereby agree as to said limited warranty to defend all and singular the said property unto the said Grantee herein its heirs, successors, executors, personal representatives, and assigns against every person whomsoever claiming or to claim the same or any part thereof.
