Production Graph of Search Results



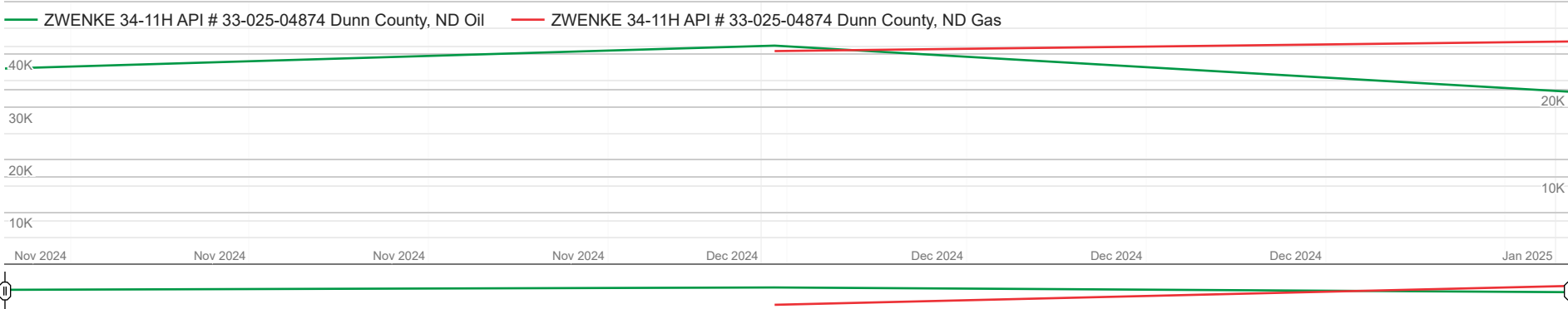
