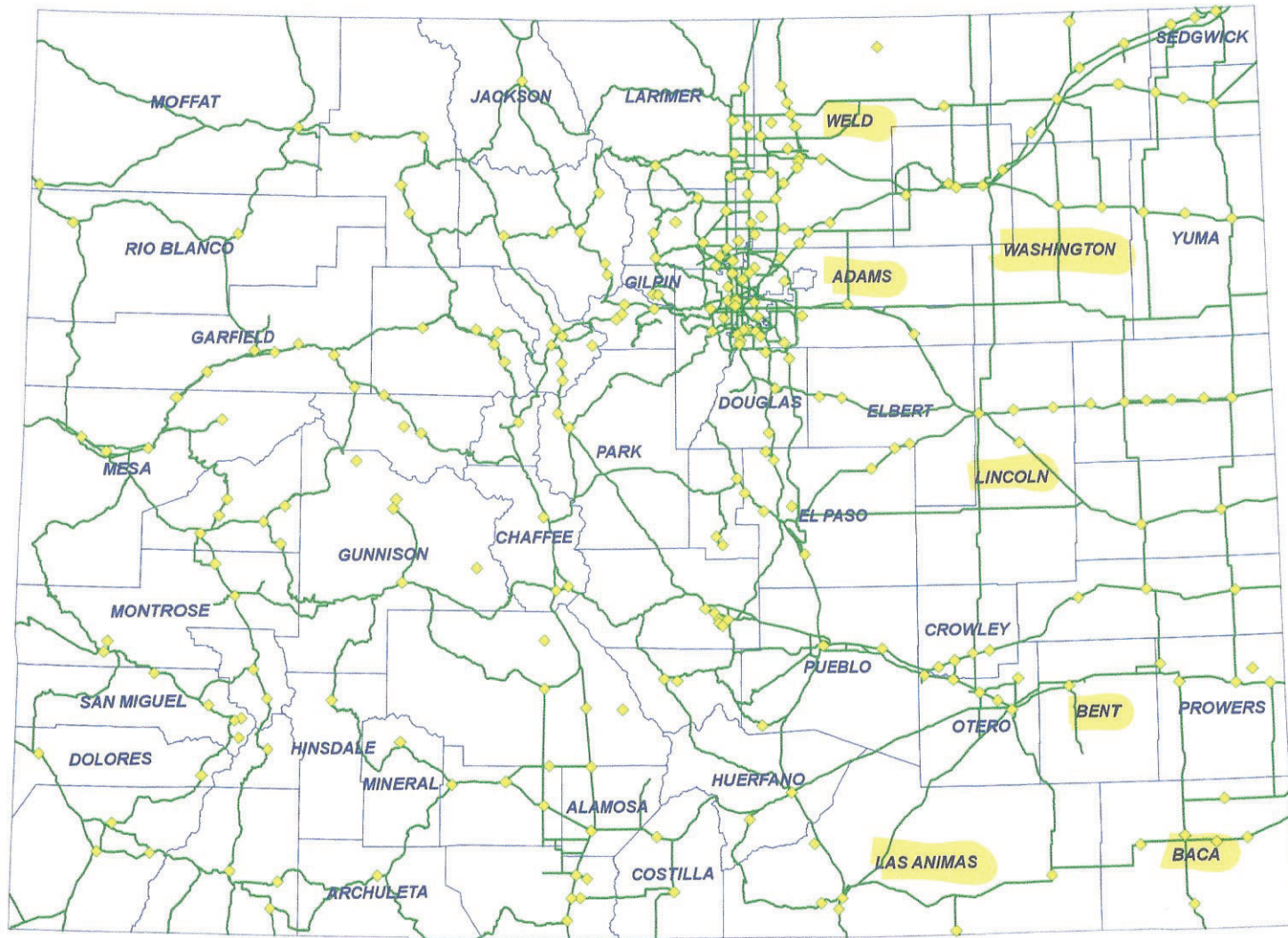

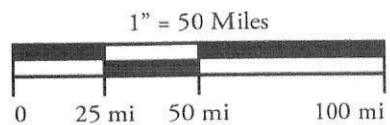


Colorado County Map
