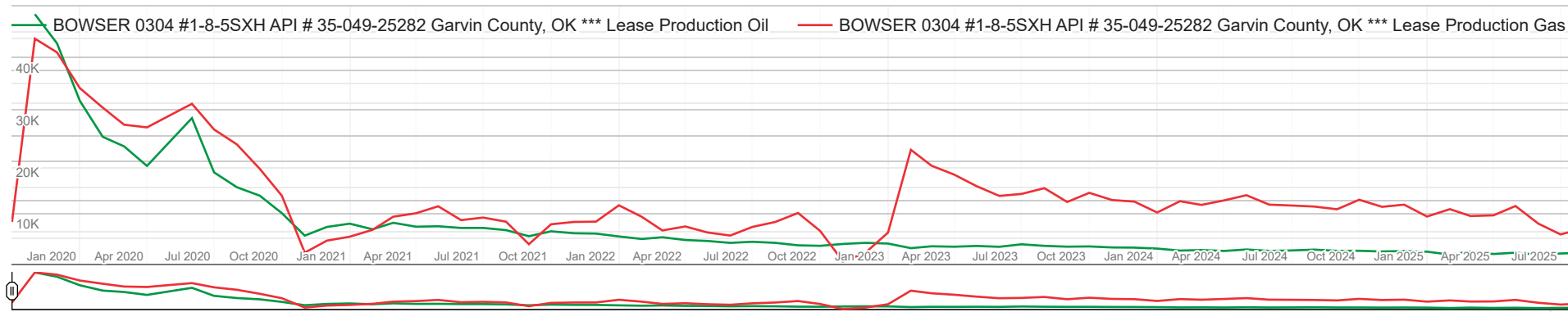

Production Graph of Search Results



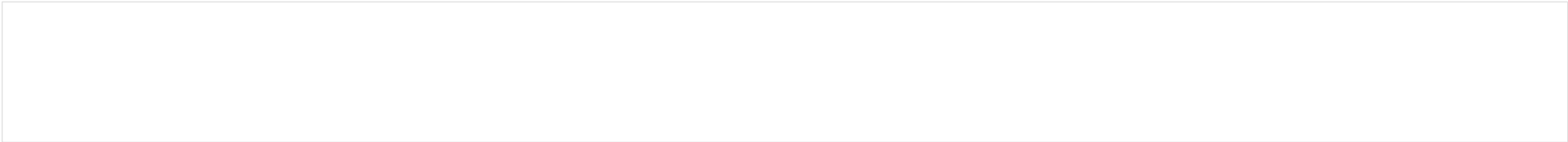

Production Graph of Search Results



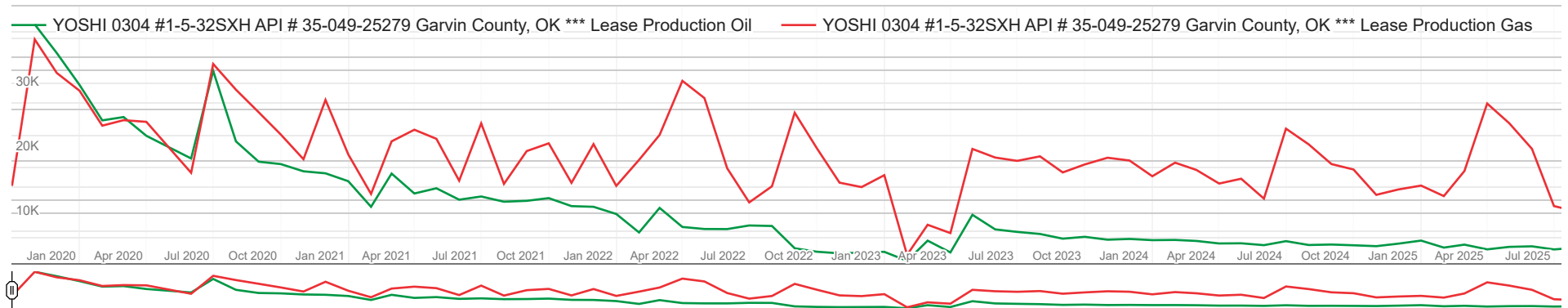
