Description

Seller owns 3.75 NRA of mineral rights located directly in the liquids-rich fairway of Canadian County, Oklahoma. VALIDUS ENERGY II MIDCON LLC currently has one

drilling rig on location and is actively developing 4 Wells (3 Miss 1 Deese). Each lot contains 0.375 NRA.

Mineral rights in this portion of Canadian County rarely become available, particularly within units that are actively being developed. To provide some perspective on value, below are a few recent transactions involving similar acreage located in active development units nearby:

- 5-well developments have traded around \$20,000 per acre (Coterra's Marilyn Unit, 12N-9W, Canadian County)
- 9-well developments have traded closer to \$30,000 per acre (Coterra's Roberts BIA Unit, 13N-10W, Canadian County)

It's important to note that those transactions occurred after the existing mineral owner had received approximately one year of production revenue. In other words, buyers paid those prices while missing the initial "flush" production period.
